The facilities, organisational structure and procedures were found satisfactory for the servicing of the equipment described in the attached Schedule of Recognition.

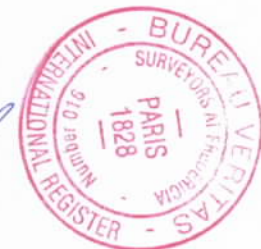
